

**“FORREST CHASE CAMPAIGN”
TERMS AND CONDITIONS**

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to WA residents aged 18 years or over. Entrants agree that in order to be eligible to win a prize, they must sign up as a subscriber of the Participating Store and remain a subscriber at the time of the draw.
3. Employees (and their immediate families) of the Promoter, Forrest Chase Shopping Centre (**“Participating Centre”**) and any of the Promoter’s agencies that are associated with this promotion are ineligible to enter.
